Family Expectations

Cub Scout Pack 131 is an inclusive organization that is welcoming to everyone. We have people from many different educational, cultural, religious, and ethnic backgrounds and we appreciate and respect all. That said, we do have a few rules that our members must follow in order to make everyone feel safe and welcome at all times. This agreement includes a summary of our expectations, but our full family expectations can be found on our website at http://pack131dekalb.org Signing this agreement constitutes agreement to this form and the extended details on our website.

Youth Protection - All leaders are required to take Youth Protection Training through the BSA's training programs. The BSA has a few firm policies that must be followed by everyone in the Pack.

- **2 Deep Leadership** All Pack events must have at least two registered adult leaders present at all times.
- **Female Leaders** In accordance with BSA safety guidelines, at any events that include female Cub Scouts a registered female adult leader must be present.
- Never Alone Adults are never to be alone, one on one, with a child that is not their own.
- **Camping** When camping, no adult may sleep in a tent with a child other than their own. Adults may not share a tent with anyone other than a family member.

No Bullying - Scouting does not tolerate any kind of behavior that can be construed as bullying, this includes physical disciplining of Scouts, verbal bullying, and any demoralizing actions by other Scouts or adults.

Respect - All Scouts and adults should be respectful at all times. This means respecting the people around us as well as the locations we are at, including our meeting space, event locations, and outdoor locations.

Positive Role Models - All adults should be positive role models for our Scouts and older Scouts should be positive role models for our younger Scouts.

No Smoking - Smoking within sight of Scouts is not allowed. If you do smoke, please do so away from any Scouts, even if that means you need to leave a camp or location that we are at. This includes vaping and e-cigs.

No Alcohol - Alcohol is not allowed at any Cub Scout events.

No Marijuana or Recreational Drug Use - Marijuana and other recreational drugs, both legal and illegal, are not appropriate for any Cub Scout events.

No Profanity - Please use child appropriate language around the Scouts.

No... - Please use common sense. Don't bring anything illegal, immoral, or otherwise inappropriate to any Scouting events. This includes things like firearms, fireworks, weapons, drugs, pornography, etc.

Etc. - The BSA has a long list of rules that spell out what is and isn't appropriate in a Scouting environment, however for the most part common sense will be fine. If you have a question if something is allowed, please ask. But if you keep in mind the Scout Law you should be fine.

I, ______, parent of ______, agree to adhere to the above rules and agree to enforce these rules with my family. I understand that violation of these rules by any member of my family may result one or more of the following: my family being asked to leave the event where the violation occurred, removal from the Pack, reporting to the BSA, or even reporting to legal authorities. Pack 131 has a zero-tolerance policy for any actions that may constitute harm to any children at our events, whether registered with the Pack or not.
